Ohio Advocates for Medical Freedom (OAMF) is urging support for HB73 regarding the
Medical Right to Refuse. This is expected to go to a vote as early as next Tuesday the 22nd.
We need to reach out to our legislators to push for a YES vote on this issue. The bill's

discrimination based on the fact.

- HB51 the Second Amendment Protection Act is still in house committee. We might think that gun rights are an easy win in this state, but that's far from the truth! The House Bill 51 Committee Activity report from the second hearing in committee on the 7th of March 22 proponents showed up to advocate for SAPA, but between the 4th and 5th hearings (14th of March and the 23rd of May), more than 130 opponents (and only one proponent) showed up to shoot down a constitutional approach to gun rights via the 10th Amendment. Still think that pursuing gun rights is "virtue signaling?" I sure don't! This is a big uphill battle and we need to get involved. If we can't affect the state, we need to pursue this at the township, city, and county level. Link to the legislation and progress is here: https://ohiohouse.gov/legislation/135/hb51.
