#### Chair

- Issue One: Seems that every single conservative-leaning organization out there was pushing for this to pass. All seemed to be OK with the fact that this would destroy any concept of citizen initiatives in the future. I don't know why they suddenly decided that they trust the legislature, except that they want to stop the "reproductive rights" bill in November, which has interesting ramifications for trans issues, especially where parental control is considered. (Will cover what happened.)
- HB51 the Second Amendment Protection Act is still in house committee. We might think that gun rights are an easy win in this state, but that's far from the truth! The House Bill 51

Committee Activity report from the second hearing in committee on the 7th of March 22 proponents showed up to advocate for SAPA, but between the 4th and 5th hearings (14th of March and the 23rd of May), more than 130 opponents (and only one proponent) showed up or wrote to shoot down a constitutional approach to gun rights via the 10th Amendment. Still think that pursuing gun rights is "virtue signaling?" I sure don't! This is a big uphill battle and we need to get involved. - MOST IMPORTANT: We need to work on local issues and get locals elected to government
  positions. Joshua Toms is the only member we have running for election right now. He's
  good on the issues, has some good ideas for what should be done to change Lebanon's City
  Council, and please get involved to support his efforts ASAP. Volunteer and show up! Petition

- LPO is going full-bore on ballot access, again. This is a recipe for wearing out volunteers by pursuing futility and hurting our grassroots movements. We need to build the grassroots and gain some level of critical mass in the state *before* we pursue this. When we have that, gaining ballot access will be a lot easier.
