 - Meeting reschedule results questionable reach of 452, no messages/conversations/engagements of note
 - Post bashing the two-party system did great! Reached almost 2000 people, got almost 500 engagements (300 reactions, 80 shares, 40 link clicks, 30 comments).
 - Last ad campaign I ran for engagement I spent \$16 and only reached 80 people so this did WAY better. So far I've only spent \$7 on this post.
 Audience for this one was "Page likes" and lookalike audience so we're

getting visibility from all over the country and political spectrum. Will need to target better next time.
